As many of you are now aware, the Town Board has approved a proposal from Johns Disposal to transition garbage collection to fully automated service, just like recycling. Please make note of the following changes:

1. **Johns will deliver brand new 96-gallon BROWN containers** to each home during the week of **December 23**. Delivery will begin on Monday, 12/23 and will take several days. Smaller 48gallon carts will be available upon request.
2. **Collection will take place every week.** *Your current collection day will remain unchanged.*
3. **Garbage Collection** (like automated recycling collection) will remain limited to what can be contained in your new cart. Additional carts are available from Johns for an annual fee.
4. **Bulk Items** – For items which will not fit in your new cart, Johns Disposal will collect these up to once per month at no additional cost. This includes tires (2 per month, up to 8 per year), motor oil (1 gallon or larger containers, sealed), furniture, white goods, extra bagged trash, etc. You must call Johns at 262-473-4700 to select your collection week. Additional information regarding cart placement will be provided when carts are delivered. Pursuant to Chapter 174.05(2) of WI Statues, all dogs, more than 5 months of age, shall Annually obtain a dog license and are required to have Rabies Vaccinations and Dog Licenses.

Dog Licenses

Licenses may be obtained at the Town Hall during normal business hours. If you are unable to do this during Office hours, you may mail a copy of the current rabies vaccination, self-addressed stamped envelope along With the proper fee to the Town Hall Office, and the Clerk will mail the license tag to you.

Spayed/Neutered- \$8.00 Not Altered- \$15.00

Handicapped and duplicates have no charge. **Late fee- \$10.00/per dog for renewing after April 1st.**

Kennel (Multiple) License- \$35.00 -12 dogs and \$3.00 for each additional tag and cannot be mailed.

KENNEL (MULTIPLE) LICENSES WILL BE HAVING AN ANNUAL REVIEW EACH YEAR-YOU WILL BE NOTIFIED OF THE DATE AND TIME. "Town of Milton ordinance permits 2 dogs per dwelling"

The Courthouse has been going through many changes

Starting 12-1-2019 All visitors will have to come in through the Front Doors and through Security!!!

First Dollar Credit – If your taxable parcel has *real property improvements*, then you qualify for this; property does not have to be primary resident of owner. Personal property improvement does not qualify. Property owner does not have to apply for this credit.

Lottery Credit – If credit does NOT show on your tax statement, you must fill out a card at the County Treasurers' office, at the time of payment to receive your credit, if **you** are eligible. Cards must be filled out completely, including Tax ID number and legal description.

Conditional Use, Variance, Zoning Applications along with Bartender Licenses and Liquor Licenses: – Applied for with Town Clerk- (Forms are available on Town's Website)

Weed Control & Mowing: State Law requires that property owners destroy all noxious weeds. It is suggested that you also do your Roadside mowing.

Motor Vehicle Registration: – When registering your vehicles with the DMV, make sure you indicate they are kept in the **TOWN** of Milton, not the City, it affects Town taxes and revenues.

Burning Info: Property owners will be responsible for charges resulting from fires caused by negligence or failure to report a controlled burn. You Must call: Milton Fire Department-868-2842, Town Chairman- Bryan Meyer 774-9229 and Non- emergency 757-2244

Building Permits, Demolition Permits and Inspections: Before digging or erecting any structure on your property, (this includes vinyl or metal covered carports mounted on posts), contact David Geraths, Building Inspector at **608-697-7776**. **Penalty for building without a permit will be equal to the permit fee! Fee schedule and permits are available on the Town's website.**

Notices and Postings: Published in our official newspaper, Milton Courier. All notices are posted at the Town Hall, First Community Bank Historic Lake House Inn and on the Town's website.

Board of Review: Will be held within a 45 day time period following the 2nd Monday of May.

Town Board Meetings: Held on 2nd Monday of each month, at the Town Hall, 23 First Street. Immediately following the Planning and Zoning Committee Meeting which starts at 6:30pm, unless otherwise published.

Annual Meeting: Will be held at 6:00 pm on Tuesday **April 21, 2020**.
