

**TOWN OF MILTON**  
**ORDINANCE NO. 2022-5**

AN ORDINANCE CREATING SECTION 11 OF CHAPTER 246 REGARDING ENGINE BRAKING IN THE TOWN OF MILTON, ROCK COUNTY, WISCONSIN

NOW THEREFORE, THE TOWN BOARD OF THE TOWN OF MILTON, COUNTY OF ROCK, STATE OF WISCONSIN, ORDAINS AS FOLLOWS:

SECTION 1: Section 11 of Chapter 346 of the Town of Milton Code of Ordinances is hereby created and shall be titled "Engine Braking" and is set forth in its entirety to read as follows:

"346-11 Engine Braking

**A. Definitions.**

(1) "Engine Brakes" are any mechanical exhaust device, compression brake, or other device in a motor vehicle other than conventional brake pads and drums or disks, used for the purpose of slowing or stopping a motor vehicle.


(2) "Emergency" means a situation in which there is an imminent and immediate risk of injury to a person or damage to another vehicle or property. The term does not include situations which resulting from operating the vehicle in excess of posted speed limits or from lack of due care by the vehicle operator.

**B. Unlawful Use of Engine Brakes and Compression Brakes.** It shall be unlawful for the driver of any vehicle to use or operate, or cause to be used or operated, Engine Brakes in the Town of Milton, except in an emergency.

**C. Penalties.** Any person who is convicted of violating any provisions of this section shall forfeit not less than fifty dollars (\$50) nor more than two hundred fifty dollars (\$250) per violation. Any person who is convicted of a second or subsequent violation of the same provision of this ordinance in less than twelve months shall forfeit not less than two hundred dollars (\$200) nor more than five hundred dollars (\$500)."

SECTION 2: This Ordinance shall take effect upon passage by the Town Board and publication by the Town Clerk as may be required by Wisconsin law.
