Under Chapter 174.05 (2) of WI Statutes, all dogs over 5 months of age shall obtain a dog license annually and must have Rabies Vaccinations. 2025 License(s) are now available at the Town Hall during regular business hours. If you cannot come in, you may mail a copy of the application, proof of vaccination, payment, and a self-addressed stamped envelope to the town hall.

#### **Tax Bill Payment Options:**

- **In Person-** Rock County Treasurer’s Office (2<sup>nd</sup> Floor) **CHECK or CASH.** All Cash payments are to be made in person, do not mail cash! No card payments are accepted in the Treasurer’s Office. Card payments must be made online.
- **Online-** by credit card at [www.co.rock.wi.us](http://www.co.rock.wi.us), you will need your Tax Bill and Tax ID to complete your payment online.
- **Phone-** 855-912-7625; you will need to have your Tax Bill, Tax ID, and form of payment available/ ready when you call.
- **Payments for multiple parcels-** can be made by e-check through [GovTech](#) for \$1.00, Debit Card for \$3.95, or Credit Card at 2.29% of the transaction amount.

## **Tax Credits & Fraud Protection**

- **First Dollar Credit** – If your taxable parcel has *real property improvements*, then you qualify for this; property does not have to be primary resident of owner. Personal property improvement does not qualify. Property owner does not have to apply for this credit.
- **Lottery Credit** – If you, the property owner, are eligible for the Lottery Credit (as of January 1 of this year) and it is not shown on your tax statement, you must fill out an application and submit it with your payment to the Rock County Treasurer by January 31. Application cards for January 1, 2025 eligibility can also be filed with the Rock County Treasurer.
- **Property Fraud Alert-** is a FREE early warning service offered through the Rock County Register of Deeds. Property owners can subscribe to be alerted whenever there is recording activity associated with their name, whether it be a fraudulent deed, a lien on their property, or a legitimate document. Owners are notified by phone, email, or text.

**Wheel Tax?** If you live in the Town of Milton and are being charged an additional \$30.00 for “wheel tax” with your vehicle registration, contact the DMV. Multiple municipalities use the Milton zip code 53563. However, the wheel tax applies only to residents of the City of Milton.
